1. Names:

The name of the Society is 'The Kalgidhar Society' here-in-after called the Society.

2. Office:

The registered office of the Society shall be situated at such a place as the Governing Body of the Society may decide from time to time. At present, the office of the Society shall be located at Village Baru, Post Office Madher, Tehsil Pashhad, District Simla, Himachal Pradesh.

3. Objects:

The objects for which the Society is formed are as under:-

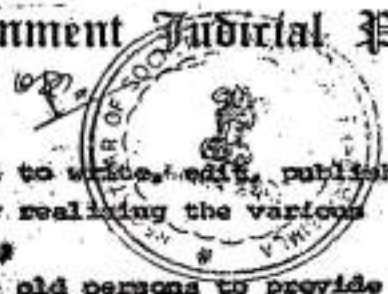
- i) to promote peace through spiritual resurrection, which is according to the wishes, blessings and guidelines of His Holiness Saint Attar Singh Ji Maharaj and Saint Teja Singh Ji, who left this world in 1927 and 1965 respectively and merged with 'God' ;
- ii) to establish the main advance centre of philosophical and spiritual studies at Saint Attar Singh Bari Ashram, Baru (Himachal Pradesh) with coordinating similar types of centres in other parts of the country ;
- iii) to provide at each centre necessary facilities such as places of worship (temples), residences with free kitchen (Langar) and other basic needs for not only devotees and spiritual students but also for the visiting persons, irrespective of any religion, caste, sex, colour or creed ;
- iv) to establish institutions for training of dedicated and devoted messengers of peace and assisting them for spreading the message of spiritual brotherhood ;
- v) to promote and develop facilities for education in Science, Technology, Humanities, religion and spirituality or any other field of human development and to open up schools, colleges or other institutions for these purposes ;

- vi) to establish libraries and to write, edit, publish and disseminate literature for realizing the various objectives of the Society ;
- vii) to establish homes for the old persons to provide them basic needs and suitable environment for peaceful living and attaining spiritual bliss ;
- viii) to render help and assistance to helpless orphans, widows, handicaps, 'Punglas' and other weaker sections of the society and mankind as well as needy persons affected by natural calamities like flood, famines, earth-quake, wars and other disturbances ;
- ix) to provide health cover and medical aid to human beings irrespective of any religion, caste, sex, colour or creed and also to establish dispensaries, hospitals and other medical institutions for the same at various centres ;
- x) to appoint persons part-time or whole-time for achieving the aims and objectives of the Society ;
- xi) to organise educational, philosophical and spiritual training camps and 'Gurmat and Kirtan Sangams' and to undertake tours to various such type of centres in the country as well as abroad to acquire knowledge ;
- xii) to assist and support any other similar type of society and institution financially and also to carry out any other activities for the furtherance of the aims and objectives of 'The Kalgidhar Society'.

Rules and Regulations of 'The Kalgidhar Society'Rule-1.Definitions:

In these rules unless the context otherwise requires:

- (a) The Society means 'The Kalgidhar Society'.
- (b) 'The General Body' means the general body of the Society.
- (c) 'The Governing Body' means the Governing Body of the Society.
- (d) 'The President' means the President of the Governing Body of the Society.
- (e) 'The Associate President' means the Associate President of the Governing Body of the Society.
- (f) 'The Vice President' means the Vice President of the Governing Body of the Society.
- (g) 'General Secretary' means the Principal Secretary of the Governing Body of the Society.
- (h) 'Joint Secretary' means the Joint Secretary of the Governing Body of the Society.
- (i) 'Adviser' means the Adviser of the Governing Body of the Society.
- (j) 'Treasurer' means the treasurer of the Governing Body of the Society.
- (k) Year means the period commencing from 1st April to 31st March.

Rule-2.Memberships:

- (a) Every member of the Society shall pay a subscription of Rs. 10/- per year. He shall cease to be a member of the Society if he fails to pay his subscription for three months without any reasonable cause. He may be re-admitted on payment by him of all arrears.
- (b) All members shall have the right to vote at the meeting of the General Body.
- (c) The Governing Body shall have the discretion to admit any person as member to the society with a majority vote to whom it considers fit by virtue of his having rendered outstanding services to the Society in furtherance of the objects of the Society.

Rule-3.Authorities of 'The Kalgidhar Society'

The authorities of the society shall be:

- (a) General Body.
- (b) The President.
- (c) The Governing Body.
- (d) Such other authorities as may be constituted by the Governing Body to give effect to the aims and objects mentioned in the Memorandum of Association and provisions of these rules.



Rule-4.General Body.

The General Body shall consist of all the members of the Society.

Rule-5.Governing Body.

- (a) The General Body shall be the supreme Body of the Society.  
 (b) The first Governing Body shall consist of the following eleven members:-

- (c) Till such time as the first regular Governing Body of the Society is not constituted, the management of the Society shall vest in the members of the society mentioned in Rule 5(b) who shall constitute the 'an Interim Governing Body'.
- (d) The President of the Governing Body shall be the Chief Executive of the Society.
- (e) The President of the Governing Body shall have an additional casting vote in case of a tie.
- (f) A member of the Governing Body may resign from the Governing Body by addressing a letter to the President.

Rule-6.

- (a) A member of the society shall cease to be a member thereof under the following conditions:-
- (i) Death
  - (ii) Resignation
  - (iii) Insanity
  - (iv) Insolvency
  - (v) Conviction by Court of Justice of an offence involving moral turpitude.
  - (vi) Continued absence from two consecutive meetings of the General Body without sufficient cause.

Rule-7.Filling up of vacancy.

The vacancy in the membership of the General Body caused by reasons mentioned in Rule 6(b) (i to vi) shall be filled up in accordance with the provision of these rules by a majority vote.

Rule-8.Procedure for Election of the Governing Body.

- (a) The total number of the members shall be eleven.
- (b) The election of the members of the Governing Body will be held in the General Body meetings of the Society by a majority of vote of the members present.

- (c) The quorum for the meeting of General Body will be  $1/3$  of the total number of its members of the Society.
- (d) The elected members of the Governing Body will in turn elect the President by a majority vote.
- (e) The President will then nominate other office bearers for the Governing Body of the society viz. Associate President, Vice President, General Secretary, ~~xxxxx~~ Secretary, Adviser and Treasurer etc.

Rule-9:Meetings:

- (a) The annual General meeting of the General Body shall be held at such time, date and place as may be determined by the President or General Secretary or Secretary authorised by him. In general, the meeting will be convened in the month of April.
- (b) The President may also convene a General Body meeting of the society, when he thinks necessary.
- (c) Six members of the General Body including at least three members of the Governing Body may by a letter addressed to the President at least 21 days in advance requisition a special meeting of the General Body. On receipt of such requisition, the President shall convene a meeting.
- (d) At all the meetings of the General Body,  $1/3$ rd of the total numbers shall constitute the quorum.
- (e) The meetings of the General Body shall be convened by the President by giving a three weeks clear notice to all the members of the Society specifying therein the place, date and time of the meeting.
- (f) The meeting of the Governing Body shall be convened by the President once in 6 months or at shorter intervals, if necessary.
- (g) The meeting of the Governing Body shall be convened by the President by circulating a notice to all the members of the Governing Body at least 21 days in advance.
- (h) At all the meetings of the Governing Body  $1/3$ rd members shall constitute the quorum provided that, if a meeting is adjourned for lack of quorum and then meets again to transact the same business, no quorum shall be necessary.
- (i) At the meetings of the General Body as also of the Governing Body, the President shall preside over and in his absence, the Associate President will preside over, Vice President will preside over when both President and Associate Presidents are absent. In the absence of all three, any member of the Governing Body may be voted to the Chair.





Rule-10:

Business by circulation of Papers:

The Governing Body may dispense of urgent matters by circulation of papers on the initiative of the President.

Rule-11:

Powers of the Governing Body:

- (a) The Governing Body of the Society shall have the powers to frame regulation and to alter, amend and repeal them from time to time for the administration and management of the affairs of 'The Kalgidhar Society' and for carrying out its objectives in accordance with the provisions of Societies Registration Act.
- (b) To prepare and sanction budget estimates, the sanctioning of expenditure, making and execution of contracts, the investment of funds of Society and accounts and audit.
- (c) President shall have the power to nominate any Prominent Person as Patron, Adviser or Chief Consultant etc. for furtherance of objectives of the Society.

Rule-12:

Bye Laws:

'The Kalgidhar Society' may frame bye-laws which are not inconsistent with the Memorandum of Association, Rules and Regulations, and Societies Registration Act, 1860 for carrying out the purpose of the Society for its day to-day administration.

Rule-13:

Subject to the Memorandum of Association, Rules and Regulations, the Governing Body shall have the powers:

- (a) To enter into arrangement with the Govt. of India, State Governments and other Public or Private Organisations for implementation of its programme and for securing and accepting endowments, grant-in-aid, donations or gift on mutually agreed terms and conditions.
- (b) To acquire by gift, purchase, lease or otherwise any property, movable or immovable, which may be necessary or convenient for the purpose of the Society and to construct, alter and maintain building or buildings for the purpose of the Society.
- (c) To draw, accept, endorse, discount and negotiate promissory notes, bills of exchange, cheques or other negotiable instruments with the Central or State Governments.

- (d) To invest the funds of the Society in such securities or in such manners as may, from time to time, be determined by the Governing Body and, from time to time, to sell or transfer such investment.
- (e) To take over and acquire by purchase, gift, donations or otherwise from Governments and other institutions/organisations, public or private bodies as well as from individuals movable or immovable properties or other funds, together with any attendant obligations and engagements not inconsistent with the objectives of the Society.
- (f) To appoint staff part-time or whole-time for conducting the affairs of the Society and fix remuneration for the staff appointed and to define their duties and obligations towards the Society. The Society can also engage the services of the prominent intellectuals, philosophers, scientists and educationists, part-time or whole-time and fix their remuneration, allowances perquisites and afford them the necessary facilities for the performance of their duties.

Rule-14:Appointment of Committee or Sub-committee:

The Governing Body may by a majority resolution appoint:-

- (a) Committees or sub-committees for such purpose and with such powers as it may think proper; and
- (b) Advisory Committees or panels with such advisory functions as the Governing Body may think proper;
- (c) The Governing Body may dissolve any of the Committee or sub-committee at any time.

Rule-15:Funds of 'The Kalgidhar Society'

The funds of the Society shall consist of the following:-

- (a) Income from the assets of the Society;
- (b) Donations;
- (c) Gifts and endowment;
- (d) Grant-in-aid from the Central and State Governments;
- (e) Aid from other Public and Private Institutions/organisations, Enterprises and Individuals;
- (f) The funds of the Society shall be deposited in Nationalised Banks and shall not be withdrawn except by a cheque signed by the President and one of the members of the Governing Body or by such other two members of the Governing Body as may be duly empowered in this behalf by the Governing Body.
- (g) The Bank Account of the Society shall be in the name of 'The Kalgidhar Society'.

- (h) All expenditure paid out of the fund shall be incurred solely for the promotion of aims and objects for which the Society has been established in the manner approved by the Governing Body.

Rule-16:Dissolution:

If upon the dissolution of the Society, there shall remain after the satisfaction of its liabilities any property, the same shall not be paid or distributed amongst the members of the Society or any of them, but shall be given over to some other similar type of society with comparable purposes according to the procedure laid down under the applicable law in the Societies Registration Act XXI, 1860.

Rule-17:Suits:

The Society can sue or be sued in the name of President or the General Secretary.

Rule-18:Accounts and Audit:

The Society shall maintain such books of accounts in relation to its receipts and expenditure in such manner as the Governing Body may determine in consultation with the Auditors of the Society. The annual account of the Society together with the audit report thereon shall be laid before the General Body at its annual meeting as far as practicable. If the statement of audited accounts be not ready by the date of the annual meeting, it shall be placed before the General Body at the subsequent meeting.

Rule-19:Amendments:

Amendments to the Rules and Regulations of the Society shall be made by the General Body only by the majority vote at a meeting convened specifically for the purpose in accordance with the provisions laid in the Societies Registration Act, 1860.

Rule-20:Act XXI 1860:

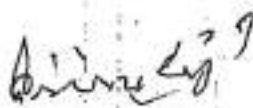

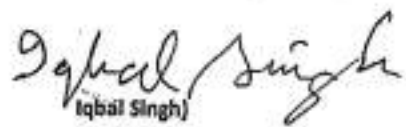
